CASE MANAGEMENT ORDER NO. 11

In order to set case deadlines for cases in Case Groups 7 and 8, the Court enters this Case Management Order No. 11. Case Group 7 consists of cases in which a Conditional Transfer Order is filed with the Clerk of this Court or the case is transferred from within this District to the MDL after July 31, 2010 and on before October 31, 2010. Case Group 8 consists of cases in which a Conditional Transfer Order is filed with the Clerk of this Court or the case is transferred from within this District to the MDL after October 31, 2010 and on or before January 31, 2011. The provisions of all other Case Management Orders remain in effect, except to the extent revised by deadlines set forth in this Order. Nothing in this Order shall preclude a party from seeking remand to a transferor court upon the completion of necessary discovery, or the transfer of cases from one Case Group to another Case Group as appropriate.

I. Deadlines for Group 7 Cases

The deadlines set forth below shall apply to cases in Case Group 7.

III. Settlement Conference Schedule

Case Management Order No. 10 did not set specific dates for settlement conferences for Case Group 6. Accordingly, the Court will set the dates for Group 6, Group 7 and Group 8 settlement conferences in this Order.

Settlement conferences to mediate or discuss settlement of MDL cases jointly selected by the parties from Case Groups 6, 7 and 8 shall occur on or about the following dates:

1. Weeks of March 19 and March 26, 2012: Cases jointly selected from Case Group 6

- 2. Weeks of June 18 and June 25, 2012: Cases jointly selected from Case Group 7
- 3. Weeks of September 17 and September 24, 2012: Cases jointly selected from Case Group 8

The parties may adjust the scheduled dates for settlement conferences by agreement and may include by agreement cases from any case group in any of the periodic settlement conference schedules.

IV. Due Date for CMO for Case Groups 9 and 10

On or before January 18, 2011, the parties shall submit to the Court an agreed Case Management Order containing all case deadlines for Case Groups 9 and 10. (If the parties have differing versions of such CMO, they shall separately submit their versions of the CMO with a brief of up to three pages supporting their version.)

V. Modification

The parties and Court acknowledge that modification of this CMO may be necessary based on experience operating under it, and any party is free to seek modification of this Order for good cause shown.
