ORDER ON STATUS CONFERENCE

This case was called in open court on September 28, 2022, for a status conference.

The Court and counsel discussed the procedural posture of the case. This matter is currently scheduled for a trial by jury on October 25, 2022. Pending before the Court is Defendant Kyle Meany's ("Meany") motion to declare the case complex (DN 22) This motion is unopposed by the United States or Defendant Joshua Jaynes. The United States advised the Court that it will be providing additional extensive discovery in the case and suggested the jury trial be rescheduled for some time in the fall of 2023. Defense counsel requested that current pretrial deadlines be remanded, no pretrial deadlines be set at this time, and that the matter be continued for another status conference in approximately ninety (90) days. The parties being in agreement and the Court being otherwise sufficiently advised,

IT IS HEREBY ORDERED as follows:

1. The motion of Defendant Kyle Meany to declare the case complex (**DN 22**) is **GRANTED**. This case is declared **COMPLEX** for the reasons stated on the record.

2. The jury trial scheduled for October 11, 2022, is **REMANDED** from the Court's trial docket and will be rescheduled at an appropriate time by further order of the Court. This matter is **SCHEDULED** for a **telephonic status conference on February 21, 2023, at 2:00 p.m. EDT. Counsel for the parties shall connect to the telephonic status conference by dialing the toll-free number 888-684-8852 and entering access code 2068314#. Parties shall dial into the conference (5) minutes prior to the Conference.** Participation in the telephonic status conference by Defendants Jaynes and Meany is not mandatory. Should defense counsel desire to have their client participate, they may do so at defense counsels' offices.

3. The pretrial deadlines established in the August 5, 2022 Pretrial Order (DN 14) are **REMANDED**. Pretrial deadlines will be rescheduled by further order of the Court.

4. Defendants Joshua Jaynes and Kyle Meany shall remain under the terms and conditions of their present bonds.
