# FORMS AND INSTRUCTIONS for FILING A SOCIAL SECURITY APPEAL CASE

### 1) Social Security Complaint form

The complaint must be legibly handwritten or typewritten on the form provided by the Court. It must be signed by the *pro se* plaintiff. All questions must be answered concisely in the proper space provided on the form. Do NOT write on the back of any page. **Keep a copy of the complaint for your files. The current fee for filing a civil action may be located at https://www.kywd.uscourts.gov/court-fees** 

#### 2) Civil Cover Sheet form

Complete the Civil Cover Sheet to the best of your ability, and be sure to sign and date at the bottom. The Civil Cover Sheet should be filed with your complaint.

### 3) Summons forms and USM-285 form\*

For service of your case against the Social Security Administration, you must serve: (1) the Commissioner of Social Security; (2) the Attorney General of the United States; and (3) the United States Attorney for the Western District of Kentucky. The service addresses for all three are set forth in the next section below. Service upon the United States, and its Agencies, Corporations or Officers must be in accordance with Federal Rule of Civil Procedure 4(I).

When you file your complaint and Civil Cover Sheet with the Clerk's Office, you are required to tender completed summons forms for service as set forth in the previous paragraph. If you are requesting to proceed *in forma pauperis* or without prepayment of fees, a USM-285 form must be completed for each of the three tendered summonses. If you are granted leave to proceed *in forma pauperis* or without prepayment of fees, the Clerk of Court will issue and forward the summonses, with a copy of the complaint and the completed USM-285 form to the United States Marshal Service (USMS) for service.

\*The USM-285 form is required only if you are requesting to proceed *in forma pauperis* or without prepayment of fees.

#### 4) Non-Prisoner Application to Proceed Without Prepayment of Fees *form*

If you are unable to pay the filing fee, you should complete the Non-Prisoner Application to Proceed Without Prepayment of Fees form. Either the filing fee or the request to proceed without prepayment must be included with the filing of the Complaint.

#### FILING YOUR CASE WITH THE COURT

Upon completion of the Social Security Complaint, Civil Cover Sheet, tendered Summonses, and USM-285 forms (if applicable), you may either mail or hand-deliver the documents for filing at any one of the following Clerk's offices in the Western District of Kentucky. If you are unable to pay the filing fee, you must also include your Non-Prisoner Application to Proceed Without Prepayment of Fees. (Note: If you reside in a county outside of the Western District, you will need to consult with that district's filing procedures. If you are unsure, you may call any of the numbers below to confirm that you reside in a county in which the Western District has jurisdiction.)
