Regina S. Edwards has been appointed United States Magistrate Judge for the U.S. District Court for the Western District of Kentucky and shall enter on duty July 28, 2018. Therefore,

IT IS HEREBY ORDERED that effective July 28, 2018, Judge Edwards shall be placed on the civil draw as set forth in General Order 2018-01. Effective August 30, 2018, Magistrate Judge Edwards shall be designated in and assigned cases as set forth in General Orders 2018-01 and 2018-02.

IT IS HEREBY FURTHER ORDERED that any social security case or any civil case in which a person is seeking relief under 28 U.S.C. § 2255, or in which the United States, a United States agency or corporation, or a United States officer or employee is sued in an official or individual capacity that is filed between July 28, 2018 and August 30, 2018 and assigned to the Louisville division shall be randomly and equally assigned among Magistrate Judges King, Brennenstuhl and Lindsay. Any criminal case filed within this same timeframe and assigned to the Louisville division shall be assigned to Judge Lindsay unless otherwise directed by the Court.

IT IS HEREBY FURTHER ORDERED that, effective July 28, 2018, all pending cases referred or assigned to Judge Dave Whalin are referred or reassigned to a magistrate judge as set forth below for consent, where agreed, or where there has been no consent for all pretrial, non-dispositive matters and for findings of fact, conclusions, and recommendations for disposition. All cases so reassigned shall henceforth carry the suffix initials of the judges to whom such cases have been reassigned.

- (2) The list of cases annexed hereto as Exhibit B are reassigned to Judge King.
- (3) The list of cases annexed hereto as Exhibit C are reassigned to Judge Brennenstuhl.
- (4) The list of cases annexed hereto as Exhibit D, including all cases pending on Judge Whalin's Ft. Knox docket, are reassigned to Judge Lindsay.
