GENERAL ORDER NO. 20-16

IN RE: REASSIGNMENTS OF CASES ON THE DOCKET OF JUSTIN R. WALKER

WHEREAS, Judge Justin R. Walker has been appointed to the United States Court of Appeals for the District of Columbia Circuit and has informed the United States District Court for the Western District of Kentucky of his intent to resign as District Judge of the Court effective September 2, 2020, it is necessary to reassign his pending cases.

IT IS HEREBY ORDERED that, effective September 2, 2020,

- 1. All cases now pending on Judge Walker's Bowling Green docket shall be reassigned to Judge David J. Hale.
- 2. All cases now pending on Judge Walker's Paducah docket shall be reassigned to Senior Judge Thomas B. Russell, except that any cases from which Senior Judge Russell has already recused or would have to recuse shall be reassigned to Chief Judge Greg N. Stivers.
- 3. All civil cases pending on Judge Walker's Louisville docket shall be reassigned among Chief Judge Greg N. Stivers, Judge David J. Hale, Judge Rebecca Grady Jennings, and Judge Claria Horn Boom. Chief Judge Stivers shall be reassigned all civil cases that have pending motions which were submitted to a District Judge for decision prior to January 1, 2020. The Clerk of the Court shall randomly reassign the remaining civil cases among the judges identified above in such percentages that provide for a relatively equal distribution of cases among those judges, with Judge Boom receiving roughly 50% of the cases reassigned to Judges Hale and Jennings.
- 4. All criminal cases pending on Judge Walker's Louisville docket shall be reassigned among Chief Judge Greg N. Stivers, Judge David J. Hale, Judge Rebecca Grady Jennings. Chief Judge Stivers shall be reassigned all criminal cases that have pending motions which were submitted to a District Judge for decision prior to January 1, 2020. The Clerk of the Court shall randomly reassign the remaining criminal cases among the judges and in such percentages that provide for a relatively equal distribution of all case so reassigned.

Based upon the foregoing, IT IS HEREBY FURTHER ORDERED that,

- (a) The list of case annexed hereto as **Exhibit A** shall be reassigned to Chief Judge Greg N. Stivers.
- (b) The list of case annexed hereto as **Exhibit B** shall be reassigned to Judge David J. Hale.
- (c) The list of case annexed hereto as **Exhibit C** shall be reassigned to Judge Rebecca Grady Jennings.
- (d) The list of case annexed hereto as **Exhibit D** shall be reassigned to Judge Claria Horn Boom.
- (e) The list of case annexed hereto as **Exhibit E** shall be reassigned to Senior Judge Thomas B. Russell.

IT IS HEREBY FURTHER ORDERED that all magistrate judge assignments on any of the listed cases will remain as previously ordered. All cases so reassigned shall henceforth carry the suffix initials of the judge to whom the case is reassigned.

IT IS HEREBY FURTHER ORDERED that on the Court's own motion, any case heretofore closed and previously assigned to the docket of Judge Walker in which a motion or other pleading requiring a judicial decision is filed is referred to the Clerk of this Court for random reassignment to another judge.

IT IS SO ORDERED.
