NO. 22-12**

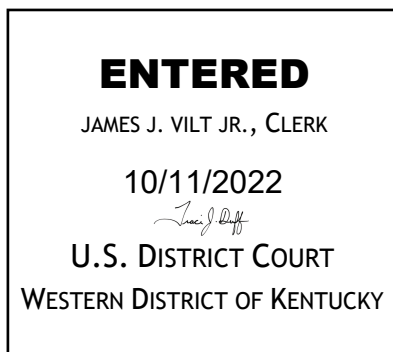
